



And whereas, in exercise of the powers conferred by Section 3 of the UGC Act, 1956, the Central Government vide its Notification No.9-23/2005-U3 dated 05.01.2009, on the advice of UGC, had declared Lingaya's Institute of Management & Technology, Faridabad as deemed to be University in the name & style of 'Lingaya's University' for the provisional period of five years, with effect from the date on which the aforesaid Institute disaffiliates itself from its affiliating University viz. Maharshi Dayanand University, Rohtak, Haryana. This was subject to condition that the status of deemed to be University shall be confirmed after the period of 5 years based on the inspection and assessment report of UGC's Expert Review Committee and the recommendations of the UGC thereon.
  - And whereas, UGC is in the process of reviewing the functioning of Lingaya's University (Deemed to be University), Faridabad as required by this Ministry's Notification dated 05.01.2009.
  - 4. And further whereas, the Hon'ble Supreme Court of India vide its judgment Order dated 03.11.2017 in Civil Appeal Nos. 17869-17870/2017 (arising out of SLP(C) Nos.19807-19808/2012) filed by Orissa Lift Irrigation Corp. Ltd Versus Rabi Sankar Patro & Ors. and Civil Appeal Nos.17902-17905/2017 (arising out of SLP C Nos.35793-96/2012) titled as Vijay Kumar & Ors Vs. Kartar Singh & Ors held that UGC shall take appropriate steps for implementing Section 23 of the UGC Act and restraining Deemed to be Universities from using the word 'University' within one month from today.

And whereas, Section 23 of the UGC Act, 1956 says "no institution, whether a corporate body or not, other than a University established or incorporated by or under a Central Act, a Provincial Act or a State Act shall be entitled to have the word "University" associated with its name in any manner whatsoever: Provided that nothing in this section shall, for a period of two years from the commencement of this Act, apply to an institution which, immediately before such commencement, had the word "University" associated with its name".
- 6. Now, therefore, in exercise of the powers conferred under Section 3 of the UGC Act, 1956, the Central Government, as per direction of Hon'ble Supreme Court, and on the advice of the UGC, do hereby change the name of "Lingaya's University", Faridabad, Haryana to "Lingaya's Vidyapeeth" by replacing the word 'University' with 'Vidyapeeth' w.e.f. the issuance of this Notification. "Lingaya's Vidyapeeth" shall not use the word 'University' suffixed to its name but may mention the words "deemed to be university" within parenthesis suffixed thereto.
- The other conditions mentioned in the earlier Notification dated 05.01.2009 shall continue to be adhered by "Lingaya's Vidyapeeth".



## 24. Moot court exercise and Internship:

This paper may have three components of 30 marks each and a viva for 10 marks.

- (a) Moot Court (30 Marks). Every student may be required to do at least three moot courts in a year with 10 marks for each. The moot court work will be on assigned problem and it will be evaluated for 5 marks for written submissions and 5 marks for oral advocacy.
- (b) Observance of Trial in two cases, one Civil and one Criminal (30 marks):

25. Minimum Period of Internship:

(a) Each registered student shall have completed minimum of twelve weeks internship for Three Year Course stream and twenty weeks in case of Five Year Course stream during the entire period of legal studies under NGO, Trial and Appellate Advocates, Judiciary, Legal Regulatory authorities, Legislatures and Parliament, Other Legal Functionaries, Market Institutions, Law Firms, Companies, Local Self Government and other such bodies as the University shall stipulate, where law is practiced either in action or in dispute resolution or in management.

End Semester Test: No student of any of the degree program shall be allowed to take the end semester test in a subject if the student concerned has not attended minimum of 70% of the classes held in the subject concerned as also the most court room exercises, tutorials and practical training conducted in the subject taken together.

Provided that if a student for any exceptional reasons fail to attend 70% of the classes held in any subject, the Dean of the University or the Principal of the Centre of Legal Education, as the case may be, may allow the student to take the test if the student concerned attended at least 65% of the classes held in the subject concerned and attended 70% of classes in all the subjects taken together. The similar power shall rest with the Vice Chancellor or Director of a National Law University, or his authorized representative in the absence of the Dean of Law.





#### 9. Cautions

The following cautions shall be noted and exercised while submitting online application on PCI portal for consideration of approval for academic session 2022-2023.

- i) The Last date for completing the application process on PCI portal will not be extended under any circumstances and hence institutions are required to apply online in SIF without fail within the available window from 01.12.2021 to 15.12.2021. The institutions are advised not to wait for the last date for submission of SIF as overcrowding may pose technical problems. The Council will not be responsible in case institution is not able to apply on time. It is reiterated that the last date will not be extended and no further time will be granted to complete the application process.
- ii) All Institutions that are already approved by the PCI for conduct of course / approved under section 12 for registration as a pharmacist for the D.Pharm / B.Pharm / M.Pharm / Pharm.D, Pharm.D (PB) / B.Pharm (Practice) programs have to mandatorily apply on the PCI portal, submitting all the requisite information and Pharmacy Education Regulatory Charges for consideration of approval.

  - a) teaching staff details (Name, qualification, specialization at PG level (very important), Years of experience etc).

  - c) the staff names that are reflected in an institution, as per the PCI circular dt.9.10.2013, a copy of which is enclosed as Annexure-D will be not counted for the number of staff for the particular program if they have left the institution to join another institution in the same academic year.
  - d) the staff whose name is reflected in an institution presently for the academic year 2022-23 will not be given credit in another institution for the year 2022-23 even if they join another institution during the said period. Such information should be clearly informed by the faculty to the joining institution and the PCI. 
