Ownership of Intellectual Property

- If the intellectual property is created in the course of the employment or under the direction of Lingaya's Vidyapeeth, First applicant for filing the patent will always be Lingaya's Vidyapeeth. Lingaya's Vidyapeeth shall be the owner of such intellectual property.
- Lingaya's Vidyapeeth will bear all the charges of patent attorney and government fee.
- If the intellectual property is created by the faculty, staff, or researchers using the Vidyapeeth's resources, facilities, or funding, the Vidyapeeth shall have a non-exclusive, irrevocable, worldwide, royalty free license to use such intellectual property for its non-commercial purposes.

- If the intellectual property is created by the student using the Vidyapeeth's resources, facilities, or funding, the Vidyapeeth shall have a non-exclusive, irrevocable, worldwide, royalty-free license to use such intellectual property for its non-commercial purposes.

Commercialization of Intellectual Property

Lingaya's Vidyapeeth encourages the commercialization of its intellectual property for the benefit of the society and the Vidyapeeth. The commercialization of intellectual property shall be carried out in accordance with the following principles.

- · The commercialization of intellectual property owned by Lingaya's Vidyapeeth shall be done through competent authority.
- The commercialization of intellectual property owned by the faculty, staff, or researchers of Lingaya's Vidyapeeth shall be done through the Vidyapeeth's competent authority, and the owner of the intellectual property shall receive a share of the royalties or proceeds from the commercialization.
- The commercialization of intellectual property owned by the students of Lingaya's Vidyapeeth shall be done through the Vidyapeeth's competent authority, and the student shall receive a share of the royalties or proceeds from the commercialization.

Lingava's Vidyapeeth shall encourage the creation of start-ups and spin-offs based on the intellectual property owned by the Vidyapeeth, its faculty, staff, and students.

Protection of Intellectual Property

Lingaya's Vidyapeeth shall take all necessary measures to protect its intellectual property from infringement and unauthorized use.

The Vidyapeeth shall take appropriate measures to ensure that the intellectual property owned by the faculty. staff, and students is protected from infringement and mauthorized use.
